Sealed quotations are invited for upkeep and maintenance of potted plants and arrangements of cut flowers in the office of NCRB, East Block-7, R.K. Puram, New Delhi. The vendor should have minimum three years experience of Horticulture. Total 250 potted plants and cut flowers for 6 senior officers are required for the period of one year. However, initially contract will be awarded for a period of one year but in case Bureau shifts its new location at Mahipalpur during the contract period, contract will be terminated and dues of the vendor will be paid on monthly basis. The premises where the said arrangements is to be made can be inspected between 10.00 AM to 5.00 PM with prior appointment with JAD(G) at telephonic No. 26172324 Ext.208 on any working day. The quality / type of potted plants required are plants like Aerocaria, Raphis Palm, P Oxycodium, Areca Palm, Aurocaria, Raphis Palm, Ph. Zanadu, Areca Palm (specimen) etc., Agloneama Varr., Crotons phonix palm, provision of arrangement of cut flowers on alternate days for 6 Officers (one cut flower has 30 mix flowers and 5 other cut flowers have 18 to 20 flowers like lily, carnation, Roses and orchid etc. ) and summer / winter seasonal Annual and other small foliage plants. The term and conditions of the quotation are as below.

1. Quotations received after due date and time will not be entertained.
2. The successful firm shall have to deposit a refundable security deposit equivalent to the one month cost of potted plants / flowers before awarding the work.
3. The rates quoted should include taxes like VAT, Service Tax WC and educations cess etc.
4. Quotations should be accompanied by an EMD for an amount of Rs. 5000/- in the form of Bank draft drawn in favour of A.O. PAO, DCPW at New Delhi. Cheaque will not be entertained.
5. A copy each of last three year ITR filed and copy to TIN No. should be enclosed.
6. Rates should be quoted per day for cut flowers and for plants per month.
7. Quotations should reach to Asstt. Director(A&G), NCRB, East Block-VII, R.K. Puram, New Delhi-110066 on or before 24.05.2016 by 1700 hrs.
