

TERMS & CONDITIONS

1. Locally manufactured will not be considered.
2. The Bidder should be Authorized Distributors/Dealers along with Number and date of the certificate/dealership authorization letter issued by original machine manufacturers for having appointed the bidders as the authorized seller/distributor of machines.
3. Name/s, contact number/s of authorized person/s of any five government organization/s to which the bidder has supplied photocopier machines in the past (attach document in Lieu of the same).
4. The Earnest Money Deposit of Rs. 25,000/- (Rupees Five thousand only) by way of D.D. only drawn in favour of "AO, PAO, DCPW" payable at New Delhi shall be submitted along with Technical Bid.

The offers without EMD will be rejected. However, there is exemption of EMD applicable to the units registered with Central Purchase Organization (DGS&D), National Small Industries Corporation (NSIC) or the concerned Ministry or Department as defined under Rule 157 of General Financial Rules (GFR), 2005. A copy of valid certificate shall be enclosed along with the Technical bid for availing EMD exemption.

5. The Tenderer shall submit the copy of PAN along with the Technical Bid of the tender document.
6. The tender shall be placed in a properly sealed bigger envelope addressed to Director General, National Crime Records Bureau, East Block-7, R.K. Puram, New Delhi-110066 containing two separate sealed envelopes containing Technical and commercial bids.
7. The envelope shall be super-scribed as "Tender for Supply of Photocopier Machine". The two sealed envelopes inside the bigger envelope must be super-scribed as: Envelope No-1: TECHNICAL BID - Tender for Supply of Photocopier Machines. Envelope No-2: COMMERCIAL BID - Tender for Photocopier machines.

 - a) Technical bid evaluation: NCRB will scrutinize the technical offers. In the evaluation, NCRB will determine whether the technical details along with documents furnished are as per bid requirements and whether items are quoted as per the annexure. If the bidder proposes to supply "Photocopier Machines" which are equivalent or higher performance than the specified machines, the bidder should necessarily include documents in the technical bid, to establish such claim to the satisfaction of the Tender Inviting/Accepting Authority.
 - b) Commercial Bid Evaluation: Commercial bid offers of only those bidders, who qualify technically, shall be opened.
 - c) Technical Bids and Commercial Bids will be opened by the Evaluation Committee respectively in **Conference Hall, National Crime Records Bureau, East Block-7, R.K. Puram, New Delhi-110066**, in the presence of the participating Bidders/Vendors, who may wish to be present.
9. Should have direct support centers at Delhi/NCR. In case of support through service partners details of customers supported by the service partners to be attached.
10. Quoted price shall remain valid for three months from day of 1st supply order issued.
11. The rate should be quoted inclusive of all taxes etc.
12. No advance payment shall be made against supply order.
