The annual "All India Board Examination for Finger Print Experts 2020" will be held at **Central Finger Print Bureau, NCRB, National Highway 8, Mahipalpur, New Delhi-110037 from 10.10.2020 to 12.10.2020**. The programme of Examination is as follows:

12 <sup>th</sup> October 2020 (Monday)	10:00 hrs. -17:00 hrs	Viva-voce*

\* If the number of candidates exceed 50, viva voce would continue on 13.10.2020 (Tuesday).

Syllabus for the examination has been enclosed. Educational qualifications and experience to appear in this examination are as follows:

- c) Candidate must have at least three year experience in Finger Print Bureau/ FP Unit / CFPB as technical hand as on 20.12.2020.
- d) Candidate must be a Science Graduate from a recognised university at the time of submission of application.

**Exception:** As decided in the XIX<sup>th</sup> Finger Print Director's Conference, non-science graduate would be allowed to take the examination under the condition that State / UT FPBx must give an undertaking that recruitment rules will be revised enforcing science graduate as minimum eligibility criteria and the nominated list is to cover and exhaust already recruited employees.

It is requested that nomination of the eligible candidates of your Finger Print Bureau/Unit in the prescribed form (Copy Enclosed) for appearing in the above examination may be sent through the appropriate authority to the **Secretary, All India Board Examination for Finger Print Experts 2020, CFPB, NCRB, National Highway 8, Mahipalpur, New Delhi- 110037** latest by **Friday, 31<sup>st</sup> August 2020**. Nomination received after the date would not be entertained. This letter in Hindi version is overleaf.
