### A. Amendments from May 2018

- States/UTs have been categorized in following categories of similar states for comparison and inline with divisions of States/UTs by MHA.
  - Non CAS States
  - CAS States
 CAS States have been further divided into following categories-
  - Major States including Delhi
  - North East States and J&K
  - UTs excluding Delhi.
- The following changes are made in PRAGATI Dashboard:
  - Overall Weightage of PRAGATI Dashboard has been reduced from 245 to 200.
  - Two new Parameters ('No. of PSs visited by Senior Officers during the month' with weightage of 10 and 'No. of PSs able access the Digital Police Portal' without weightage) have been included.
  - Weightage of three parameters ('Entry of IIF-8 to 11 & other Forms', 'Legacy Data Migration' and 'Fund Utilization') has been reduced from 15 to 10.
  - The parameter namely 'IT Cadre (technical team) prepared in the State for CCTNS' is renamed as 'Technical Setup for handling CCTNS'
  - Weightage (Marks) of two Parameters ('Technical Setup for handling CCTNS', 'Data Replication to NDC') has been excluded from the Overall Weightage.
  - Two Parameters ('No. of PSs entering IIF-1 to IIF-5 in CAS' and 'Quality of CCTNS Data checked') have been removed.
- During the Review meeting of CCTNS Nodal Officers of all States/UTs under the chairmanship of Director, NCRB and Joint Secretary (WS), MHA held on 26.06.2018 at NCRB, one Committee comprising of Representative from Gujarat, Odisha and NCRB was formed for reviewing the PRAGATI Parameters. PRAGATI Dashboard will be further revised on the basis of suggestions received from this Committee.

### B. Amendments in June 2018

- State Category 'North East States and J&K' has been changed to 'Hilly States' and two more states (Himachal Pradesh and Uttarakhand) have been included in this category as per classification in Police Modernization scheme.
- Weightage of 'Data Replication to NDC' (5) has been included in overall weightage.
- Two more Activities (Disposal of Complaint requests and Verification requests received through Digital Police Portal) have been included in the Dashboard without considering their weightage in overall weightage.
- Calculation of Activity 'CCTNS generated IIF-1 (FIR) submitted to court' has been changed from IIF-1 to average of IIF-1, IIF-3, IIF-4 and IIF-5. Its weightage also has been changed from 10 to 20.
- Weightage of 'No. of PSs visited by Senior Officers during the month' has been excluded from overall weightage.
- Weightage of 'Entry of IIF-8 to 11 & other Forms' has been revised from 10 to 15.
- Weightage of 'SMS Alert activated in CAS' has been revised from 5 to 10.

### C. Amendments in July 2018

- Parameter "Data Replication to NDC" has been replaced by "Replicated Data at NDC". Under this parameter, percentage is calculated on the basis no. of IIF Forms (IIF 1 to 11) replicated at NDC (Data extracted from NDC Server) out of Total no. of IIF Forms actually filled in all Police Stations (Form no. 3 - Details of Registration and Entry of IIF Forms). Weightage of this parameter has been given as 20 marks.
- Weightage of 'CCTNS used for generating Reports and Registers at PS level' (5) has been excluded from overall weightage.
- Weightage of 'No. of PS able to access Digital Police Portal' has been given as 10.
- Weightage of two parameters "No. of IIF 1 to 7 in CAS" and "No. of IIF 8 to 11 & other forms in CAS" has been revised from 25 to 20 and 15 to 10 respectively.
- Total Marks are now 215.

### D. Amendments in August 2018

- The replication of Data at NDC is treated 100% if entry in CCTNS software of IIF-7(Result of Appeal form) is zero "0", but if data replication of all forms is nil then it is considered as 0%.
- Following three new parameters have been added in PRAGATI Dashboard:
  - Data Bank Services forms entry in CCTNS (Weightage - 10)
  - Usage of search & queries of CCTNS (Weightage - 10)
  - Reports generated through CCTNS in PS (Weightage - 10)
- Total Marks are now 245.

### E. Amendments in September 2018

- Data syncing at SDC calculation has been revised. No. of PSs syncing on same day has been given 100% weightage and no. of PSs syncing in 1 to 7 days has been given 50% weightage.
- Calculation for Replicated data at NDC also has been changed. Now it is being calculated for no. of IIF 1 to IIF 6 replicated at NDC.

### F. Amendments in October 2018

- Target of Nagaland for Data Digitization and Migration revised from 231087 to 16144.
- Calculation for CCTNS generated IIF-1 to IIF-5 Form submitted to court has been changed to CCTNS generated IIF-1.

### **G. Amendments in November 2018**

1. Parameter " Replicated Data at NDC" has been excluded from overall weightage.

### **H. Amendments in December 2018**

1. Nagaland: decreased total no. of Police Stations from 77 to 65 as 12 non functional PSs.

### **I. Amendments in January 2019**

1. Nagaland provided the status of Go Live as 'Partial declared on 15-Oct-2013' with stating that they missed to report this in earlier reports.

2. Jharkhand added 70 new notified functional PSs (437+70=507).

3. Gujarat reduced total no. of Police Stations from 714 to 713 as one PS is non operational.

4. Goa reduced No. of Police Stations able to access Digital Police Portal from 38 to 23 with stating that the audit of the Digital Portal is currently going on and the same is likely to be completed soon. Once the report is received, NCRB will request NIC to open the port for allowing the accessing of the portal at 15 Police Stations.

### **J. Amendments in February 2019**

1. Goa: Target for Data Digitization and Migration has been revised from 72000 to 42474 records.

2. J&K: Total no. of PSs revised from 219 to 218 as one PS is not physically established.

3. Jharkhand : reduced total no. of Police Stations from 507 to 506 as FIR is being registered at 506 PS only.

4. Odisha: Target for Role Base Training has been revised from 25786 to 25476.

### **K. Amendments in April 2019**

1. Odisha: Go-live status revised from Partial to fully declared on 18.03.2019

2. Himachal Pradesh: reduced network connectivity from 145 to 141 with stating that 4 PSs are newly created and presently working offline.

3. Meghalaya reduced the no. of Police Stations where CCTNS Software deployed from 49 to 44 due to the reason that the 5 PSs are yet to make entry on CAS due to the unavailability of Operators to man the system.

### **L. Amendments in May 2019**

1. Jharkhand: reduced total no. of PSs from 506 to 505 as 1 PS doesn't exist by Physical or logical till date.

2. Jharkhand: reduced No. of PSs having Network Connectivity from 495 to 491 with stating that provided 4G dongle are not working on those 04 Sites.

3. Uttar Pradesh: reduced No. of PSs having Network Connectivity from 1506 to 1498

### **M. Amendments in June 2019**

1. Parameter " Replicated Data at NDC" (20 Marks) has been included in overall weightage. Total marks of all activities included in overall weightage is 245.

2. Haryana : reduced total no. of PSs from 348 to 332 with stating that 16 PSs are either not present or not registering any FIR.

3. Meghalaya : reduced total no. of PSs from 62 to 58 with stating that 4 PSs are currently Non-feasible for deployment as they are functioning from temporary buildings and not fit for installation of CCTNS equipment.

4. Tripura : reduced PSs having network connectivity from 76 to 67 with stating that 7 VSAT & 2 Wimax locations are deducted as presently these locations do not have any service due to expiry of SLA with BSNL.

### **N. Amendments in July 2019**

1. Mizoram : Target for Role Base Training has been revised from 3847 to 3597.

2. Haryana increased total no. of PSs from 332 to 336 & Tripura increased total no. of PSs from 82 to 83.

3. Bihar: the network connectivity figure has been provided as 569.

4. Madhya Pradesh reduced No. of PSs having Network Connectivity from 1046 to 1045.

5. West Bengal reduced No. of PSs having Network Connectivity from 598 to 461

6. Nagaland : Target revised for Data Digitization from 16144 to 15529 and Role Base Training from 2777 to 943.

### **O. Amendments in Aug 2019**

1. Information not received from J & K and West Bengal. Hence, the data taken from previous month report.

2. Sikkim reduced No. of PSs having network connectivity from 26 to 21.

3. Uttar Pradesh reduced No. of PSs having network connectivity from 1507 to 1491.

4. Chhattisgarh increased total no. of PSs in State from 439 to 441.

5. Haryana increased total no. of PSs in State from 336 to 342.

6. Nagland reduced No. of PSs having connectivity from 51 to 50.

### **O. Amendments in Sep 2019**

1. Information not received from West Bengal. Hence, the data taken from previous month report.
2. Haryana increased total no. of PSs in State from 342 to 348.

### **P. Amendments in Oct 2019**
